Cascade Whippet Club

Code of Ethics

This code shall establish a standard of conduct to be followed by members of the Cascade Whippet Club, when engaged in conducting Club activities, and in a normal course of breeding, exhibiting, selling and judging of purebred dogs.

As a Cascade Whippet Club member in good standing, I agree:

1. To promote the welfare and quality of purebred dogs;
2. To conduct myself and my activities in such a manner as to benefit the Cascade Whippet Club and in no way to interfere with the quality of purebred dogs and function of the club;
3. To adhere to and comply with all rules and regulations of the American Kennel Club, Inc. in regards to purebred dogs;
4. To study, to inquire, to learn and to familiarize myself with all available information on purebred dogs, in particular Whippets and breeding, as to type, conformation, proper care of the bitch and her litter, and the stud dog;
5. To ensure that all purebred dogs in my care are provided with adequate food, water, shelter, and proper veterinary care;
6. To not sell pups, whole litters, or breeding stock to such as pet dealers, catalog houses, or to other commercial sources or give my dogs in a contest as prizes or for any other exploitations;
7. To honestly enter breeding for the betterment of the breed and to ensure that all purebred dogs are sold/placed in good condition, free from communicable disease with a health guarantee for a reasonable length of time;
8. To not deliberately breed "mixed breed" dogs;
9. Members should provide written agreements on all transactions that involve breeding and sales contracts and to honor all agreements into which I enter;
10. To adhere to the principles of truth in advertising;
11. To conduct myself in such a manner as to reflect credit on the dog show sport and the Cascade Whippet Club in particular; and
12. To enter into club activities with a sportsmanlike attitude, engaging in and cooperating on as many activities as possible.

All members shall be shown a copy of this code when joining the Cascade Whippet Club, and by the act of joining shall signify acceptance of this code in its entirety with their signature.
